Adam Bence Balázs is a lecturer at the German Andrássy University in Budapest and the Bratislava International School of Liberal Arts. Formerly a post-doctoral researcher at Sofia University St. Kliment 'Ohridski' and a visiting fellow at the Graduate Institute (IHEID) in Geneva, he holds a Master's degree in Political Science from Central European University, Budapest, and a Ph.D. in Political Philosophy from LCSP, Paris 7. Francesca D'Alessandris is currently a Ph.D. candidate in Humanities and Educational Sciences at the University of Modena and Reggio Emilia. Her research project focuses on the role of aesthetic experience in learning processes. She already obtained a joint doctoral degree in Philosophy from the Fondazione San Carlo of Modena and the Ecole des Hautes Etudes en Sciences Sociales of Paris, where she defended her thesis on Paul Ricœur's philosophy of the person. She published several articles and essays in international peer-reviewed journals on Paul Ricœur's philosophy, specifically on narrative identity, memory and the philosophy of lived space.

Andrzej Gniazdowski (1964) is a philosopher, translator and historian of ideas. His areas of competence are the history of the phenomenological movement and the history of radicalism. His publications include Philosophy and Guillotine. The Traditionalism of Joseph de Maistre as a Political Hermeneutics (pol. 1996) and The Antinomies of Radicalism. Political Phenomenology in Germany 1914-1933 (pol. 2015). As associate professor at the Institute of Philosophy and Sociology of the Polish Academy of Sciences, he focuses his research on the project The Phenomenology of the State. A Critical-Historical Introduction. He has published in "Phainomena", "Horizon" and "Les Études Philosophiques", amongst others.
